| 4 | Employment Covering Letter from the Indian organization or company mentioning the designation and current profile of the applicant, purpose of the visit, itinerary, name & contacts of the company in Portugal with complete and full address and contacts of host / hotel accommodation in Portugal. | | |

| 8 | Overseas travel medical insurance valid for all Schengen-countries .The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure India. | | |
| 9 | Police Clearance Certificate issued from Passport Office (not required for minors below sixteen years) in English and duly translated to Portuguese. | 10 | Proof of sufficient funds to cover expenses during the stay in Portugal: self supporting means paid by the company/ scholarship or any other means of sponsorship. | | |
| 11 | Declaration form granting SEF (Foreign and Borders Office) permission for consulting criminal record in Portugal (not required for minors below sixteen years) | | |
| 12 | Sponsorship Proof: If the applicant is sponsored by another person, an original Sponsorship Letter is required on Rs. 100 Stamp Paper and must be Notarized. If the Sponsor is in not in India, the Sponsorship Letter should be Notarized/Attested by a Notary/Advocate if in the E.U. or from the respective Portugal Consulate/Embassy in other countries. | | |
| 13 | The Passport should be valid for at least three months beyond the intended duration of stay in the Schengen territory and with at least two blank pages to affix the visa.
