1	Online Visa Application Form completely filled and signed by the applicant (Date on Online Visa Application form should be the same date as the appointment for visa submission).		
2	One Recent (not older than six months) passport-size photographs in color with white background. (3.5cm / 4.5cm) (Do not staple / without Glasses-Specs)		
3	Cover Letter from the Indian recruiting company stating the applicants name and rank, vessels name and arrival date at the port in Portugal. Date of joining vessel, the Name and Address of the handling agent in Portugal.		
4	Reserved Onward Travel Flight Ticket .		
5	Overseas travel medical insurance valid for all Schengen-countries .The insurance has to cover the applicant at least for 30,000 Euros or equivalent for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.		
6	Fax or Letter from the Shipping Company or Agent in Portugal confirming the dates of arrival & departure of the ship		
7	Declaration from the ‘Port Authority’ (in Portugal) regarding the arrival of ship.		
8	Photo Copy of the CDC booklet (Seamen’s Booklet).		
9	The Passport should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Schengen territory and with at least two blank pages to affix the visa. No visa will be issued on the additional page of the passport.		
	Copy of the Bio-Pages (first and last page) of the Passport.
