3	Personal Covering Letter from the applicant introducing himself/herself, explaining the purpose, duration & itinerary of the visit in brief. The cover letter should also mention the name and relation of any accompanying travelers with their passport numbers. and passport copy If the accompanying travelers already possess a valid Schengen Visa, please enclose a photocopy of the same and if applying through another Embassy/Consulate, please provide the details.		
4	Original No Objection Certificate from the current Institute/School		
5	Proof of acceptance (Invitation) in a course of study/ research work /training programme in a recognized University/Institute/company		
6	Reserved Onward / Return Travel Ticket . Flight ticket accompanying travellers (if any).		
7	Internal Travel Tickets/Reservations if travelling to more than one country within Schengen area.		
8	Overseas travel medical insurance valid for all Schengen-countries .The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure India.		
9	Proof of Accommodation (confirmation of reservation of Hotel/Apartment).		
10	Police Clearance Certificate issued from Passport Office (not required for minors below sixteen years) in English and duly translated to Portuguese. The documents shall be attested with “APOSTILLE” sticker by the Ministry of External Affairs, Consular Division, and Patiala House, New Delhi. <ul style="list-style-type: none"> ➤ PCC In English Language: Apostille ➤ PCC Translated In Portuguese Language : Apostille 		
11	Proof of sufficient funds to cover all expenses during the stay in Portugal: self supporting means (i.e. Bank Statement for the last three months) & documentary proof that the applicant is a beneficiary of scholarship/grant sponsored by the Portuguese authorities, European Union or a company.		
12	Sponsorship Proof: If the applicant is sponsored by another person, an original Sponsorship Letter is required on Rs. 100 Stamp Paper and must be Notarized. If the Sponsor is in not in India, the Sponsorship Letter should be Notarized/Attested by a Notary/Advocate if in the E.U. or from the respective Portugal Consulate/Embassy in other countries. *If the Sponsor is in not in India <ul style="list-style-type: none"> ○ Bank Statements for the last 6 months ○ Copy IT Returns Form-V for the last 3 years and Copy of Pan Card ○ Copy Salary Slips for the last 3 months (if working).
