1	<b>Online Visa Application Form</b> completely filled and signed by the applicant (Date on Online Visa Application form should be the same date as the appointment for visa submission).		
2	<b>One Recent</b> (not older than six months) <b>passport-size photographs</b> in color with white background. (3.5cm / 4.5cm)		
3	<b>Original Personal Covering Letter</b> from the applicant introducing himself/herself, explaining the purpose, duration & itinerary of the visit in brief. The cover letter should also mention the name and relation of any <b>accompanying travelers</b> with their passport numbers and passport copy If the accompanying travelers already possess a valid Schengen Visa, please enclose a photocopy of the same and if applying through another Embassy/Consulate, please provide the details.		
4	<b>Original Covering letter</b> from the Indian organization or company mentioning the designation and current profile of the applicant, purpose of the visit, itinerary, name & contacts of the company in Portugal with complete and full address and contacts of host / hotel accommodation in Portugal.		
5	<b>Work Contract / Invitation Letter / Declaration of acceptance from the University or Institute in Portugal</b>		
6	Reserved Onward / Return <b>Flight Travel Ticket</b> .		
7	Overseas travel medical insurance valid for all Schengen-countries .The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure India		
8	<b>Proof of Accommodation</b> (confirmation of reservation of Hotel/Apartment).		
9	<b>Police Clearance Certificate</b> issued from Passport Office (not required for minors below sixteen years) in English and duly translated to Portuguese. The documents shall be attested with “APOSTILLE” sticker by the Ministry of External Affairs, Consular Division, and Patiala House, New Delhi. <ul style="list-style-type: none"> <li>➤ PCC In English Language: Apostille</li> <li>➤ PCC Translated In Portuguese Language : Apostille</li> </ul>		
	<b>Proof of sufficient funds to cover all expenses while in Portugal</b> paid by the company/ scholarship or any other means of sponsorship: <ul style="list-style-type: none"> <li>○ Copy Salary Slips for the last 3 months (if working)</li> <li>○ Bank Statements for the last 6 months</li> <li>○ Copy of <b><u>Indian Income Tax Return Verification Form – V</u></b> for the last 3 years &amp; Copy of <b>Pan Card</b>.</li> </ul>		
10	<b>Sponsorship Proof:</b>  If the applicant is sponsored by another person in India, an original <b>Sponsorship Letter</b> is required on Rs. 100 Stamp Paper and must be Notarized. If the Sponsor is in not in India, the Sponsorship Letter should be Notarized/Attested by a Notary/Advocate if in the E.U. or from the respective Portugal Consulate/Embassy in other countries.
